NOTICE OF ASYNCHRONOUS LEARNING FOR FULL CONTACT HOURS:

When taking these classes on the TC campus, students have a total of 96 contact hours: 48 each for lecture and lab. Due to our high school schedule falling short with a total of 63 contact hours for the Fall semester, students will be expected to complete the remaining 33 hours outside of the regular class time. The outside hours should be a minimum of two hours per week. These outside hours may include, but are not limited to - completing lecture notes, studying for examinations, researching, conducting laboratory simulations, analyzing case studies, watching videos, writing essays, and completing virtual labs. Students can be expected to complete these hours before school, after school, and while at home.

- 1. Describe modern evolutionary synthesis, natural selection, population genetics, micro and macroevolution, and speciation.
- 2. Describe phylogenetic relationships and classification schemes.
- 3. Identify the major phyla of life with an emphasis on plants and animals, including the basis for classification, structural and physiological adaptations, evolutionary history, and ecological significance.
- 4. Describe basic animal physiology and homeostasis is maintained by organ systems.
- 5. Compare different sexual and asexual life cycles noting their adaptive advantages.
- **6.** Illustrate the relationship between major geologic change, extinctions, and evolutionary trends.

Student Assessment

- Students will be evaluated on a combination of lecture examinations, quizzes, articles and other class assignments, and a comprehensive final examination.
- The course will be broken up into unit topics. A variety of interactive, discussion posts, and practice quizzes will be assigned during each unit for practice or for a deeper understanding of content. At least one lab will be conducted for each unit. Each unit will conclude with a Quiz.

The exams will be administered on the dates given, unless material relevant for a given exam has not been covered. Under such cases, an exam may be moved a class period or two to aid in the clarity and understanding of the material.

Tutoring: Before and/or after school

Cell Phone Policy

All cell phones will be turned to silent mode (or vibrate) and kept out of sight in class. If any phones are out while testing, I will assume you are cheating. Students who are on their phones or other electronic devices during an exam or quiz will receive a score of zero. There will be no talking on phones, texting, or social media while lecture and discussion is taking place. Students are not allowed to videotape class lectures, and you are not allowed to put lecture material on social media at any time. All students must receive permission from the instructor if they wish to audio record class lectures. If you cannot abide by this policy, you will be asked to leave, or you will be dropped from the class.

Make-up Policy

Make-up exams should not be required. One make-up exam for full credit will be given. Students who miss more than one test will receive a grade of zero. If a student has an emergency that causes him or her to miss a second test, the instructor must be contacted before the test date and documentation must be provided by the student. Otherwise, a score of zero will be applied to the student's grade. Students who miss a third test or more will automatically receive a score of zero. Students will have one week to make up a missed quiz or exam. Make-up exams may differ in format from the original test. All make-up exams will be recorded as a zero until they are made up. This policy will also apply for in-class quizzes. Assignments that have a specific due date will have points deducted if they are late.

Class Behavior

There will be a zero tolerance policy for any behavior that is disruptive and prevents or deters classroom learning. This behavior includes, but is not limited to, any use of vulgar language or rude behavior towards the instructor or any other student in the class. Saving seats is not allowed in the classroom. Violation could result in being asked to leave the class, withdrawal from the course, and/or investigation by the Dean of Students. Students who are dropped from the course for inappropriate behavior will receive a grade of F.

Student Responsibilities

It is the student's responsibility to know and comply with the instructor's policy and to contact the instructor to make up for missed work.

Attendance Policy

Roll will be taken during each class. It is recommended that students contact the instructor if missing a class is necessary. A student with more than four absences may be dropped from the class for lack of attendance. If a student stops coming to class, and it is well before the end of the semester, then the student will most likely be dropped. If an enrolled student stops attending class and chooses to receive an F, the last date they attended will be listed on the final grade sheet and they will most likely have to pay back money received from grants or scholarships. If a student leaves and returns during class or leaves the class before the class is over, he/she may be considered absent. Three tardies constitute one absence.

Excused Absences: A student's absence due to school trips and/or school business will not be counted against a student's allowable number of absences. Responsibility for work missed for any absence is placed on the student. Instructors are required to allow students to make up work missed if the absence is due to military duty or religious holy days when students follow the correct notification procedures. Instructors are not required to allow students to make up work for absences due to other reasons.

Incomplete Grade Policy: Incompletes can be given if you complete 75% of the course work with at least a 70% average. Students who want an incomplete grade should meet with the instructor and make a request for the grade and have a plan for completing the required work.

Withdrawal Policy: If you wish to drop the class, please do so yourself. The instructor will not be responsible, unless you make a specific request prior to the drop deadline. The drop deadline for each semester can be found in the Texarkana College Catalogue (https://www.texarkanacollege.edu/). After the drop deadline the student that fails to complete the class with a satisfactory grade will receive a grade of "F". The student's final attendance date will be reported with the grade of "F".
